THE GOVERNING BOARD OF THE CLEAN SKY 2 JOINT UNDERTAKING,

Having regard to the Statutes of the Clean Sky 2 Joint Undertaking as annexed to Council Regulation establishing the Clean Sky 2 Joint Undertaking¹ and in particular Articles 4 and 8.2 (a);

Having regard to the amended CSJU Work Plan 2014-2015 (ref. CS-GB-2015-03-25 Doc11a WP 2014-2015 Amend. nr. 2) as adopted by the Governing Board on 25th of March 2015 and published;

Having regard to the CSJU Rules for submission, evaluation, selection, award and review procedures of Calls for Core Partners as approved by the Board on 7th of July 2014;

Having regard to the Decision of the Governing Board (ref. CS-GB-Written Procedure 2015 —07 Approving Ranking Lists of selected proposals C52-CPWO2-2015-01) of 3rd of December 2015 approving the Ranking Lists of the selected applications of the Call for Core Partners Wave 2² with a view to conducting the negotiations and its annexes;

Having regard to the enclosed list of selected Core Partners proposed for Membership that have successfully concluded the negotiations with the CSJU and its Leaders;

WHEREAS:
