THE GOVERNING BOARD OF THE CLEAN SKY 2 JOINT UNDERTAKING,

Having regard to Council Regulation (EU) No 558/2014 of 6 May 2014 establishing Clean Sky 2 Joint Undertaking, and in particular to Article 4(2)(b), 4(3), 4(4) and Statutes Article 8(2)(j) and Article 15(3)(b),

Having regard to the Grant Agreements for members of the Clean Sky 2 Joint Undertaking (hereinafter referred to as the "GAMs"), and in particular to the cost claims and in-kind contribution declarations received by 5 January 2017 by the JU for 2014¹-2015,

WHEREAS:

1) The Governing Board has received the declarations of in-kind contributions ('IKC') for Clean Sky 2 Joint Undertaking funded projects (IKOP) from the Clean Sky 2 JU private members² through the attached Table of declared amounts of in-kind contribution 2014-2015 (Annex I) and the Tables of detailed amounts supporting Annex I (Annex II).

2) The following values have been reported for GB opinion:

For Clean Sky 2 Programme (H2020):

Contributions for 2015 for a value of	33,102,945.65 €
Contributions for 2014 for a value of	6,065,648.86 €
Total	39,168,594.51 €

3) A detailed split-up of the total values into individual amounts per ITD/IAPD is enclosed to this decision.

4) The Governing Board notes that the total declared values of IKOP are supported in all material aspects by detailed statements of each member, which are certified by independent auditors of the members in compliance with the provisions set out in the Clean Sky 2 JU Regulation.

5) Cost claims for GAMs 2014-2015 have been validated by the JU's management according to the eligibility criteria of the GAMs.

Declarations about in-kind contributions have been validated by the JU's management following the validation of the reported costs.

6) The need to provide an opinion on the related in-kind contributions of private members has arisen following the Clean Sky 2 JU Regulation, Art. 8(2)(j) of the Statutes, and in order to recognize the corresponding amount in the Net Assets of the Provisional Accounts of 2016 of Clean Sky 2 Joint Undertaking.

7) Any subsequent adjustments (increase or decrease) of the values related to the above reporting periods, which may follow potential re-assessments of the related declarations in the future and will be acknowledged in a further opinion of the Governing Board.

HAS ADOPTED THE FOLLOWING OPINION:
