



## **Decision of the Governing Board of Clean Sky 2 Joint Undertaking appointing the Executive Director**

### **THE GOVERNING BOARD OF THE CLEAN SKY 2 JOINT UNDERTAKING**

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants (the 'CEOS') of the European Union, laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup> and in particular Articles 8, 9, 12, 13, 14, and 15 of the CEOS;

Having regard to Council Regulation (EU) No 558/2014 of 6 May 2014<sup>2</sup> establishing the Clean Sky 2 Joint Undertaking (CS2 JU), and in particular Article 6 (1) and (2),

Having regard to the Statutes annexed to Council Regulation (EU) No 558/2014 of 6 May 2014 establishing the Clean Sky 2 Joint Undertaking (CS2 JU), in particular Article 8(2) (f), and Article 9,

Having regard to the list of candidates proposed by the European Commission with decision of 17 October 2018,

### **WHEREAS**

- (1) Article 6 (2) of the Council Regulation 558/2014 confers on the Governing Board of CS2 JU ('Governing Board') the powers of Appointing Authority and of the Authority empowered to conclude contracts of employment,
- (2) On 17 October 2018 the European Commission proposed a list of candidates for the position of Executive Director of the CS2 JU,
- (3) On the basis of the proposal submitted by the European Commission, the Governing Board wishes to appoint Mr Axel Krein as Executive Director of the CS2 JU for a period of three years, in the grade AD14.
- (4) It is appropriate that the candidate, who succeeded in the selection procedure and based on the Commission proposed short-list for the position of CS2 JU Executive Director, is appointed as he possesses the necessary qualifications for exercising this function.

### **HAS DECIDED AS FOLLOWS:**

#### *Article 1*

Mr Axel Krein is appointed Executive Director of the CS2 JU in the grade AD14.

*Article 2*

The term of office of Mr Axel Krein shall be three years.

*Article 3*

The CS 2 JU Programme Office shall prepare the contract of Mr Axel Krein's employment to be signed, on behalf of the CS2 JU, by the Chairperson of the CS2 JU Governing Board.

*Article 4*

This Decision shall enter into force on the date the employment contract of the selected candidate.
